**CALL TO ORDER:** Rock Wilson called the meeting to order at 6:05 p.m. and led in the Pledge of Allegiance.

**GUESTS:** Steven Reynolds, EMD candidate. The Board acknowledged Steve Reynolds. Steve was interested in the vacant position for EMD. After brief discussion, the Board welcomed Steve and signed the appointment paper.

**ACTION ITEMS:** Signed bill and payroll manifest, yield tax levy, veteran credit denials; notice of violation and order; gun license for Alstead Gun Shop; intent to cut; employee pay rate sheet.

**OLD BUSINESS:** All the ceiling panels are installed at town hall.

Charlotte mentioned that Jodi would like to put the clothing box inside at the transfer station rather than outside the gate. This will be more secure and prevent any potential vandalism. All were in agreement.

Charlotte mentioned that a check for \$11,520.03 was received from Primex for the Fire Truck repairs and that Kim will take care of getting the truck in for repairs.

**NEW BUSINESS:** The Board acknowledged Bobbie Wilson. Discussion took place on whether to open Vilas Pool. The options were to open it but no swimming or boats and only open Friday, Saturday and Sunday or do not open at all and do repairs that need to be done. After some discussion the Board agreed to keep it closed for now and do repairs until the state of emergency is lifted. The Board asked Charlotte to reach out to Prescott to get update on plans to open the dam at Vilas Pool.

The Board reviewed the email from Gina Vogel regarding "Community Day" on Millot Green June 26<sup>th</sup>. All were in agreement for this to take place.

Meeting for tax deeding was scheduled for February 17<sup>th</sup> at 9:00. Rock said he wouldn't be there. (Note: after relaying this to the Tax Collector the next day it was decided to wait until after the elections.)

**MINUTES FROM PREVIOUS MEETING:** Minutes of January 26, 2021: On a motion by Joe, seconded by Mary Ann; ***the Board voted to approve the minutes as written. The motion passed unanimously.***

**PUBLIC COMMENTS:**

Prescott wanted to delay the non-public until after the deliberative since all three will be together outside. Charlotte will post there will be a Select Board meeting after the deliberative.
